### 1. Booking & Payment

1.1 A deposit of 10 % of the total retreat fee is required to secure your booking.

1.2 Full payment must be received no later than 30 days prior to the retreat start date.

1.3 All prices are in Australian Dollars and include accommodation, daily yoga sessions (Martial Yoga, Hot Stone Yoga), scheduled activities (Zen meditation, mountain walks, temple visits, workshops), and meals as specified.

1.4 Prices do not include airfare, personal travel insurance, personal expenses, or any additional activities not listed in the retreat itinerary.

### 2. Cancellations & Refunds

#### 2.1 Participant Cancellation:

- Cancellations made more than [60 days] before the retreat start date: 10 % refund of the amount paid (excluding bank/transfer fees).
- Cancellations made [31–59 days] before: 30 % refund.
- Cancellations made [30 days or less] before: No refund.

#### 2.2 Organizer Cancellation:

In the unlikely event that the retreat is cancelled by the Organizer, participants will receive a full refund of all payments made. The Organizer is not responsible for additional costs incurred, such as airfare or travel arrangements.



### 3. Travel & Insurance

- 3.1 Participants are responsible for arranging and covering their own travel to and from the designated meeting point in Japan.
  - 3.2 Travel insurance covering medical emergencies, cancellations, and lost belongings is strongly recommended.
  - 3.3 For international participants, a valid passport and any required visas are the responsibility of the participant.

### 4. Health & Safety

- 4.1 Some retreat activities involve physical exertion (e.g., yoga, walking tours, hot spring bathing). Participants should be in good physical health and consult a physician if unsure of their ability to participate.
  - 4.2 Any medical conditions, injuries, allergies, or dietary restrictions must be disclosed at the time of booking.
  - 4.3 The Organizer reserves the right to refuse participation if a health condition poses a risk to the individual or the group.

### 5. Conduct & Respect

- 5.1 This retreat takes place in sacred and cultural settings, including Buddhist temples. Participants must show respect to local customs, religious practices, and fellow guests.
  - 5.2 Disruptive, unsafe, or disrespectful behaviour may result in dismissal from the retreat without refund.

- 6.1 The itinerary is subject to change due to weather, local conditions, or unforeseen circumstances.
  - 6.2 Replacement activities or venues will be provided where possible without reducing the quality of the experience.

- 7.1 By joining the retreat, participants acknowledge and accept that the Organizer is not liable for injuries, losses, or damages incurred during the program, except where caused by proven negligence.
- 7.2 Participants join all activities voluntarily and at their own risk.
